- **Additional Work:** Gutter replacements, updated signage, and new park gates.

Ongoing Initiatives

- **Capital Improvement Plan (CIP):** 25 active projects, including North County Regional Park and Calico Rocks Park.
- **Annual Report:** Distributed, featuring native species programming.
- **FY26 Budget Appeal:** Proposal for a Teen Recreation Specialist; Parks Commission to advocate for funding.
- **Custodial Contract:** Transition underway after Scott Key Center closure; staffing for 16 buildings and libraries in progress.

Upcoming Events

- **Seasonal Programs:** Medieval Night, Mom/Son Event, holiday-themed competitions, and light displays.
- **Fall Sports Leagues:** Wrap up on 11/15 with over 3,000 participants.

County Commission discussed and approved the Budget Appeal Recommendation.

FY26 budget appeal for Teen Recreation Specialist approved unanimously and letter would be sent to support this appeal.
