Standard Operating Procedures for Events

Event/Community Building - Alcohol Permit Policy

The purpose of this policy is to provide for the use of alcohol in specific areas of County parks within the following guidelines:

1. Applicants must be 21 years of age or older and provide a copy of their valid driver's license.
2. **By signing the application, the applicant accepts responsibility for being physically present during the event, having a copy of the approved permit with them, monitoring alcohol use, and ensuring that all alcohol-related laws, rules, and regulations are followed by their attendees.**
3. Payment of permit fee is required: \$70 (Resident)/ \$80 (Nonresident) daily permit.
4. Permitted use of alcohol must only take place inside, or within twenty-five (25) feet of the permitted shelter or shelters; inside permitted indoor facilities; or within the permitted outdoor area(s) designated, where access can be controlled to the general public.
5. At no time may alcohol use interfere with, or negatively impact, other park users.
6. In the event the applicant, or members of their party, fail to abide by these rules, or other park rules and regulations, Frederick County Division of Parks and Recreation (FCDPR) reserves the right to revoke the permit and terminate an event prior to the scheduled finish time, with no refund.
7. If a permit is revoked due to violation of rules, the Frederick County Division of Parks and Recreation reserves the right to prohibit the applicant and/or the organization from renting (FCDPR) facilities in the future.
8. Areas designated for alcohol use are subject to change with the approval of the Director.

Alcohol is allowed by permit within the above guidelines at the following locations:

Ballenger Creek Park, Kemptown Park, Loys Station Park, Middletown Park, Pinecliff Park, Old National Pike District Park, Othello Regional Park, Rose Hill Manor Park, Urbana District Park, Utica District Park.

Alcohol is prohibited at the following locations: Buckeystown Park, Campus Drive Athletic Fields, Catoctin Creek Park, Creagerstown Park, Devilbiss Park, Fountaindale Park, Fountain Rock Park, Greenhill Park, Libertytown Park, Point of Rocks Community Commons Park, Point of Rocks Community Park, Rocky Ridge Landing Park, Roddy Road Park, Urbana Community Park.
